## Tax Hearing -

- > We need to do a lead test along with 7 other metals at the tower before we can do the painting. Ann will check on this.
- Randy told the railroad that they could not get water from the City. Somehow Kati Westcott told them to go to Coop and they filled them. Our system cannot take filling for long periods of time. It causes us to lose pressure in the system and causes a boil water advisory to be issued.

# Street Report -

- John asked Fred if he was going to get the ditching done. Fred said that he was unable to do it. The boards needs to talk to some different people to see if they could do it, so we can get rock put on in the spring.
- Tom Rowland said that he would look at the ton truck to see what is wrong with
  it.
