CITY OF CHULA COUNCIL MEETING October 14, 2024

The Chula Board of Alderman met in regular session on October 14, 2024, at 7:00 p.m. at the Chula Community Center.

Those present were Alderman Benny Simpson, Alderman Randy Hamilton, Alderman Geremy Bru, and City Clerk Ann Hamilton. Alderman Kyle Gramenz was absent. (Kyle arrived at 7:25 p.m.) There was a quorum present. Also, present was Fred Oertwig.

Mayor Pro Tem Benny Simpson called the meeting to order at 7:01 p.m.

Public Comment -

- > People were complaining about trucks going up Marshall Street. Fred put a barricade up so they would have to follow the truck route.
- ➤ Vicki Duckworth called and said that her mom had told her that the street next to the shop was closed and that the Ireland had purchased it in the 70's. Ann has not been able to find any information on it and it was not recorded at the courthouse. Randy Hamilton said he would look into it. Benny Simpson said that he did not remember this.
- > Dan Murphy needed the address for the Ireland properties in the flats. Ann gave the information to Fred and will email Dan Murphy the application for utilities.

<u>Approval of Agenda</u> – Geremy Bru moved to approve the agenda. Randy Hamilton seconded. Motion carried 4-0.

Rodger Pergande – Rodger has turned in his licenses and flushed the hydrants. He does not do the DMR reporting online, so Ann will have to figure out how to do it.

Water & Sewer Report –

- There 9 late fees were assessed to customers on August 28, 2024, and have not hung notices to hang for nonpayment.
- Water & Sewer Adjustments
 - Terry Hampton and Cassie Holcer are making their scheduled payments on the board approved payment arrangements.
- Chula Community Center Ann reported that the 2024 fair was a success. The Community Center has the funds to upgrade the bathrooms, making them ADA accessible and to replace the two doors. They will be working on bid specs soon.
- ➤ Park Discussed the fire at the park. Ann talked to DNR and our insurance company. Ann to get the fire report from the fire department and send Letha a letter requesting a statement on what happened, so it could be put in the file.

Kyle Gramenz seconded. Motion carried 4-0. Kyle Gramenz moved to accept Bill Number 2024-09-10-2024 as Ordinance 2024-09 an Ordinance of the City of Chula, Missouri, enter into an agreement for professional services with Allstate Consultants, LLC for the City of Chula, Missouri. Geremy Bru seconded. Roll Call Vote: Benny Simpson yes; Randy Hamilton yes; Geremy Bru yes; and Kyle Gramenz yes. Motion carried 4-0. A copy of the ordinance is attached to the minutes.
- ➤ <u>Lead Service Line Inventory</u> Ann reported that the lead service line inventory is due on October 16th. Ann has been working on the information for the report. Ann to send out another notice. Currently, we have approximately 94 responses.

New Business

➤ Kyle Gramenz moved to approve Bill Number 2024-10-10-2024 a Resolution of the City of Chula, Missouri, to remove John Graves and add Geremy Bru to the checking account at Southern Bank for the City of Chula, Missouri. Randy Hamilton seconded. Motion carried 4-0. Roll Call Vote: Benny Simpson – yes; Randy Hamilton – yes; Geremy Bru – yes; and Kyle Gramenz – yes. Motion carried 4-0. Other Business

- > Need to check with Coop to see if they need assistance putting up the street closure signs.
- > Put a letter in the water bills, stating that the city does not have a public burn site, but residents can burn on their own property. Also include not parking on sidewalks.
- ➤ Discussed the expansion of Coop. Need to go and look at the site. The board said that we cannot allow a structure on top of our mains. The gas company is going to move their line.
