

CITY OF CHULA COUNCIL MEETING

February 26, 2025

The Chula Board of Alderman met in special session on February 26, 2025, at 7:00 p.m. at the Chula Community Center.

Those present were Alderman Benny Simpson, Alderman Randy Hamilton, Alderman Jeremy Bru, Alderman Kyle Gramenz, and City Clerk Ann Hamilton. There was a quorum present.

- Ann had the information for Richard Orona on the Sunshine Law request and wanted to see if the board wanted to charge him for the time and copies. Kyle Gramenz moved to charge him for the request and Randy Hamilton seconded. Motion carried 4-0. The board said to send the letter certified mail.
